## 09/10 Rules on Overseas visitors staying longer than 90 days:

Jeremy Logan writes:

We have had a reapplication from a Chinese operator who is visiting for a year, everything we can establish from the Chinese HAM certificates indicates there is at least a bit of a gap between what they are allowed to do under class A/B and what we allow in the GURL (we allow up to 1000W and they're limited at 25W above 30MHz for instance).

I'm not happy setting a precedent of allowing the use at this time but it has prompted me to think about where the current rules sit with regard to temporary allowances for some of the weirder overseas certificates. Bit of a big question but is NZART happy with the current allowance or would you like us to relax the requirements to make it easier for visitors to be recognised? It primarily impacts your users if they don't have the requisite knowledge so may be a risk you're wanting to explore in which case we can discuss what works and what doesn't.

Recommend Working Group be formed to consider this, however clarification needs to be sought from RSM in what exactly they are looking at changing.

- a) Licence qualifications from overseas or
- b) Residency Visa's and periods of time in the country or

- c) Both
  - Need to be sure that NZ amateurs travelling overseas are not getting disadvantaged because we can't allow them to operate for over 90 days.
  - ZL2AJ/ZL2DL/ZL4FZ/ZL2TLL to meet and determine requirements of overseas visitors and in working group – ZL2DL to arrange a meeting
